Extension to cutoff date for Admission in Under-Graduate Technical Professional Courses in Engineering/Technology, Pharmacy/Pharm.D, Architecture and HMCT for AY 2019-2020

In view of order passed by Hon'ble Supreme Court of India vide M.A. No1709 of 2019 in CA No 9048 of 2012 dated 26th August 2019, the cutoff date of admission in Under Graduate Technical Professional Courses in Engineering/Technology, Pharmacy/Pharm.D, Architecture and Hotel Management & Catering Technology for academic year 2019-20 is hereby extended upto 31st August 2019.

During above extended period, Candidates who have qualified on the basis of their results of supplementary examination of 10+2 course of Maharashtra State have also been allowed to participate in the admission process. Such candidates shall register online for Non CAP admission on the website www.mahacet.org for respective admission.

Important Notes:

1. Candidate qualified on the basis of results of supplementary examination of 10+2 course must report to Facilitation Center (FC) for document verification and confirmation of Application form on or before 31st August 2019 upto 3.00 pm and then directly contact to the Head/Principal of the respective institute for admission on or before 31st August 2019 upto 6.00pm. The Head/Principal of the respective institute **must upload** the admission of the candidate through institute login **on or before 31st August 2019 upto 11.59 pm** without fail as per the directives from the Hon'ble Supreme Court of India.
2. Head/Principal of the respective institute shall follow the instructions for admission given in the Rule 13 mentioned in the Information Brochure.
3. Cancellation of admission and Refund of Fees, return of the documents by the institution shall be as per the Rule 15 mentioned in the Information Brochure as per new cutoff date.
4. List of FC is available on website. All FC shall remain open on all days including holidays and Sundays during the schedule between 10.00 a.m. to 5.30 p.m.
